

## Payment Instructions (Standard Settlement Instructions)

Please find below information to facilitate transfers in favour of your account(s) with us.

To ensure that your funds reach your account swiftly, correct information when instructing your ordering bank is key. So, when completing your bank transfer instruction, please make sure you enter the following information into the following fields:

### BENEFICIARY CLIENT:

Please always indicate your FULL NAME, FULL ADDRESS and the IBAN number of your account with us.

Please make sure you indicate the IBAN linked to the currency of your account you wish to see credited.

### BANK OF THE CLIENT:

Your account is held with us, so please always indicate our BIC/SWIFT code "NBPS CH GG".

### CORRESPONDENT BANK:

As all currencies (except CHF) must clear through a correspondent bank, please select in the table below the BIC/SWIFT code of the correspondent bank related to the currency of your payment:

3. You want to transfer **EUR** 10'000.00 to your EUR account with us, whose IBAN is CH33 4466 8800 2244 6688 0.  
Your payment must look like this:

Beneficiary Client: CH33 4466 8800 2244 6688 0

4. You want to transfer **AED** 10'000.00 to your AED account with us, whose IBAN is CH55 6677 8899 0011 2233 4.  
Your payment must look like this:

Beneficiary Client: CH55 6677 8899 0011 2233 4

5. You want to transfer **CAD** 10'000.00 to your CAD account with us, whose IBAN is CH77 8899 0011 2233 4455 6.  
Your payment must look like this:

Correspondent Bank: UBSW CH ZH 80A  
Bank of the Client: NBPS CH GG  
Beneficiary Client: CH77 8899 0011 2233 4455 6  
Mr. John DOE  
Mystery Lane 1  
London
